Katruwar Arts,Ratanlal Kabra Science And B.R.Mantri Commerce College, Manwat as developed a robust mechanism for the student grievances. There are separate committees for dealing with the grievances for male and female students. ICC deals with the grievances related to sexual abuse, while Student Grievance Redressal Cell deals with general grievances of the students. The Cell, under the leadership of Dr. Bhaskar S. Munde has been working hard for years to resolve the student grievances.

Mostly the individual grievances of the students are related with the minor complaints about the administration/library which are resolved at the Principal level. Some of the grievances are forwarded by the Principal to the Cell and then the Cell arranges a meeting and the grievance is discussed in the meeting and resolved with the help of administration. During the academic year 2022-23. The Cell received a few complaints from the students which are as follows:

1. On 07.09.2022, the B.Com. II year students wrote an application collectively to the Principal. to replace the fans in classroom number 20 and 21.


The matter was discussed in the meeting and it was resolved to forward the matter to the Management through the CDC. The Management has provided new fans after a month.


2. On 08.09.2022, the students complained about the cleanliness in the campus. The Cell arranged a meeting with the Principal and it was resolved to conduct the cleanliness drive with the help of the NSS unit, immediately.

3. On 14.08.2022, the Cell received a complaint about not cleaning the taps of drinking water. As the College provides pure and packaged drinking water, the taps have to be replaced. The administration replaced the taps of water with new ones within a week.

4. On 08.03.2023 some of the students complained about cleanliness in the halls and men toilet. The issue was brought to the notice of the administration and the class four staff was asked to clean the halls regularly. As the scavenger was on leave for a couple of days, she could not clean the toilet on the designated days. The cleanliness was resumed as soon as she returned to the work.

Few general complaints about the fighting in between the students, etc. were also received and resolved immediately by the Student Grievance Redressal Cell.



The individual and general grievances of the students are resolved at the Principal level. Some of the grievances are forwarded by the Principal to the Cell, which are then either resolved with the help of administration or forwarded to the Management through CDC. During the academic year 2021-22, the Cell received few complaints from the students which are as follows:

1. On 02.07.2021, the B.Com. 1 year students wrote an application about the inadequacy of textbooks.
The matter was discussed in the meeting with the administration and arrangements were made to purchase the more textbooks for Commerce students.
2. On 14.08.2021, the students put a demand for the spacious reading room.
It was discussed that the present reading room is inadequate and the proposal for a spacious reading room was forwarded to the Management through the CDC
3. On 07.07.2021 some of the students interested in sports requested for providing more sports facilities.
The Cell discussed the issue with the Principal and the Management and the Management gave permission to provide more facilities by strengthening the Gym.
4. On 08.08.2021 some of the students wished to have more facilities for cultural activities and an additional cultural hall.

The Grievance Cell requested the administration to provide more musical instruments and facilities to the cultural department, and if possible, allot a separate hall for cultural activities.

Few general complaints about the cleanliness of the campus, fighting among the students, etc., were also received and resolved immediately by the Student Grievance Redressal Cell.



Student Grievance Redressal Cell is responsible for the general grievances while the ICC deals with the grievances related to sexual abuse/harassments. The Cell, under the leadership of Dr. Bhaskar S. Munde, works hard to satisfy the students grievances related to administration, academics, curricular and co-curricular aspects and the facilities being provided to the students. The individual and general grievances of the students are resolved at the Principal level. Some of the grievances are forwarded by the Principal to the Cell, which are then are either resolved with the help of administration or forwarded to the Management through CDC. During the academic year 2019-20, the Cell received few complaints from the students which are as follows:

1. On 02.08.2019, ten students conveyed to the Principal that they didn't receive GOI scholarship. The issue was discussed in the meeting of the Cell and it was found that the College has completed the procedure for the scholarship, but due to some technical reasons, Social Welfare office couldn't process it in time. It was decided to take regular follow-up of the matter.
2. On 20.09.2019, the students requested the Principal to take some measure to remove the rain water logged in the campus. It is observed that a lot of water was logged in the campus and to drain the water, channel need to be dug in the campus. The issue was forwarded to the Management through The Principal and the Management solved the problem immediately.



The Cell is striving hard under the leadership of Dr. Bhaskar S. Munde to satisfy the students grievances related to administration, academics, curricular and co-curricular aspects and the facilities being provided to the students. The individual and general grievances of the students are resolved at the Principal level. Some of the grievances are forwarded by the Principal to the Cell, which are then either resolved with the help of administration or forwarded to the Management through CDC. During the academic year 2018-19, the Cell received few complaints from the students which are as follows:

1. On 13.08.2018, the girl students wrote an application to the Principal about cleanliness of the women toilet. Actually the scavenger women used to clean the toilets on regular basis. When she was approached, she told that due to some problems in the pipeline, water could not be available a couple of days in the women toilet. Immediately after that the plumber was called and the leakages in pipeline were repaired so that the cleaning was resumed.
2. On 18.09.2018, the students put a demand to increase chairs in the girls reading room for the spacious reading room. The coordinator of the Cell discussed the matter with the Principal and the number of chairs in the girls reading room were increased.
3. On 22.09.2018 some of the students came up with a complaint that they were not co-operated by the office staff. The Cell discussed the issue with the Principal and he assured that he will talk with the office staff on the issue.

Few general complaints about the drinking water, quarrel between the students, etc., were also received and resolved immediately by the Student Grievance Redressal Cell.

Nature of Work and Responsibilities:

1. To Take such measures as may be necessary for creation of awareness on sexual harassment and the rights of the women.
2. To organize workshops to promote gender sensitive safe spaces and remove underlying factors that contribute towards a hostile work environment against women.
3. To conduct capacity building and skill building programmes for the women staff and the students.
4. To provide assistance if an employee or a student chooses to file a complaint with the police.
5. To provide mechanisms of dispute redressal and dialogue to anticipate and address issues through just and fair conciliation without undermining complainant's rights, and minimize the need for purely punitive approaches that lead to further resentment, alienation or violence.
6. To protect the safety of the complainant by not divulging the person's identity, and provide the mandatory relief by way of sanctioned leave or relaxation of attendance requirement or transfer to another department or supervisor as required during pendency of the complaint, or also provide for the transfer of the offender.
7. To ensure that victims or the witnesses are not victimized or discriminated against while dealing with complaints of sexual harassment.
8. To ensure prohibition of retaliation or adverse action against a covered individual because the employee or the student engaged in protected activity.

महाविद्यालयात माननीय प्राचार्यांच्या आदेशान्वये ICC (अंतर्गत तक्रार निवारण समिती) चे गठन करण्यात आले आहे. सदरील समितीचा उद्देश आहे की महाविद्यालयातील महिला कर्मचारी आणि विद्यार्थीनी यांच्या साठी योग्य अनुकूल आणि स्वस्थ वातावरण ठेवणे आणि महिलांचे कोणत्या ही प्रकारचे शारीरिक आणि मानसिक शोषण होणार नाही या बाबतीत दक्ष रहाणे हे होय. तसेच ही समिती महाविद्यालयातील अंतर्गत गुणवत्ता हमी कक्ष (ICC) च्या आधीन राहून विविध कार्यक्रमांचे आयोजन करते. महाविद्यालयात शिक्षण घेण्यासाठी येणार्या विद्यार्थीनी आणि महिला कर्मचारी यांच्या साठी अनुकूल आणि सुरक्षिततेच्या दृष्टी ने योग्य असते. परंतु काही वेळा मुलींच्या अनावधानाने किंवा मुलांच्या काही विकृतिमुळे, परस्पर गैरसमजुतीमुळे तक्रारी येतात. त्या तक्रारी, तोंडी असो की लेखी, दूर करण्याचा प्रयत्न महाविद्यालयीन स्तरावर केला जातो. दि. 19/10/2022 रोजी महाविद्यालयातील तीन विद्यार्थीनींनी समितीकडे तक्रारी अर्ज केला. त्यांचे म्हणणे होते की त्यांच्या वर्ग मित्रांनी एन.एस.एस. च्या कार्यक्रमाचे स्वच्छता अभियानात काम करत असलेले आणि ऐतिहासिक स्थळाच्या सहलीचे फोटोज वायरल केले त्यामुळे इतरांमध्ये चर्चा होऊन मानसिक त्रास होऊन अभ्यासावर परिणाम होतो. त्यासाठी त्यांच्या मोबाईल फोन मधून त्या फोटोज Delete करावे व त्या इतरत्र जाऊ नये. संबंधित मुलांना समितीसमोर बोलावून ताकीद देण्यात आली. त्यांनी आपल्या फोनमधून संबंधित फोटोज डिलिट केले व कोणालाही पाठवणार नाही असे स्पष्ट केले.

दि. 12/1/2023 एक तक्रार महाविद्यालयातील मुलींच्या व्हीडीओ बदल आली, ती अशी की 12वी वाणिज्य शाखेच्या दोन मुलींनी नशा बंदी संबंधी व्हीडीओ पाहून दारु पीणे व सिगरेट ओढणे अशी कृती करणारी चलचित्र तैयार केली. विडिओ बनवताना तीने गणवेश घातला होता व तिच्याकडून तो विडिओ चुकीने वायरल झाला. त्यामुळे गावातील लोकांमध्ये चर्चा होऊ लागली की गावातील महाविद्यालयीन मुली दारु पिऊ लागल्या आणि सिगारेट ओढू लागल्या. चर्चा ऐकून संबंधित मुली ताणतणाव मध्ये वावरत होत्या. त्यांच्या पालकांना वाईट वाटत होतं. जेव्हा ही बाब कालेज मध्ये उघडकीस आली तेव्हा संबंधित मुलींना बोलावून विचारपूस करण्यात आली असता कळाले की इंस्टाग्राम वरचे दारुबंदीवर प्रसारित कार्यक्रम पाहून सादृश्य साहित्य घेऊन नकल करून विद्यार्थीनीने चलचित्र बनविला. ते दुसऱ्या मोबाईलवर टाकताना 'private friend list' मध्ये गेल्यावर अन्य मुलांना दिसला. तेव्हा सदर विद्यार्थीनींना ICC समितीसमोर बोलावून त्यांचे समुपदेशन करण्यात आले. त्यांनी माफी मागितली व पुन्हा असे काही करणार नाही असे लेखी लिहून दिले. त्यानंतर त्यांना तासिका करण्याची परवानगी देण्यात आली. या नंतर महाविद्यालयात संचार साधने कशा प्रकारे हाताळावीत यावर महाविद्यालयात व्याख्यान आयोजित करण्यात आले.

दि. १/२/२०२३ रोजी एक तक्रार होती की बी.ए. प्रथम वर्षात शिकणारा विद्यार्थी तिच्या वर्ग मैत्रिणीला पाहून चिडविणे, हसणे, शिट्टी वाजविणे आणि तिच्या शारीरीकतेवर टीका करणे 'शाळेतल्या मुलींचे कालेज मध्ये काय काम' वगैरे म्हणत चिडवीत होता. सदरील विद्यार्थीनीने तक्रार दिल्यावर आरोपी विद्यार्थी, त्याचे मित्र व आणि मोठ्या भावाला अंतर्गत तक्रार निवारण समिती समोर बोलावून समज दिली. त्या मुलाने माफी मागितली व त्या मुलीस सांगितले पुढे तसं करणार नाही. अर्जदार विद्यार्थीनीचे समाधान झाले. पुढे कोणताही वाद नाही. मुलींचे वैशरूम संबंधी व वर्ग खोल्या स्वच्छतेसंबंधी काही प्रश्न होते तेही प्रशासनच्या सहकार्याने सोडविण्यात आले.

तिरंगा रैलीचे दि. ११/०८/२०२२ रोजी आयोजन करण्यात आले होते. ज्यात महाविद्यालयातील बहुसंख्य विद्यार्थ्यांनी सहभाग घेतला होता. रैलीचा समारोप नगर परिषद मानवत येथे झाला.

दि. १७/०८/२०२२ रोजी महिलांचे आरोग्य या विषयांतर्गत किशोरवयीन मुलींसाठी मेळाव्याचे आयोजन करण्यात आले होते. ज्यास डॉ शरयू खेकाळे, डॉ तोडकरी डॉ इक्कर यांनी संबोधित केले.

INTERNAL COMPLAINTS COMMITTEE (ICC) FOR WOMEN

Committee Report for Academic Year 2022-23



Internal Complaints Committee (ICC), a statutory committee) has been actively engaged in resolving the women grievances over the years. The objective of the Committee is to maintain a conducive and healthy environment for the female employees and students of the college and that women should not be subjected to any kind of physical or mental abuse or sexual harassment. It also organises various programmes under the guidance of the Principal and Internal Quality Assurance Cell (IQAC) for the empowerment of women. The environment of the college is always safe for the female employees and students. The women are encouraged to bring any such complaints to the administration in written or oral form. Efforts are made by The Principal and the ICC to resolve those complaints at the college level. During the academic year 2022-23 some such complaints were received and resolved by the ICC. Few of them are mentioned below.

On 19/10/2022 three girl students of the College lodged a complaint to the ICC, that their classmate. (when they were working in cleanliness campaign NSS), took some photographs of the them and made them viral in the social media, which caused mental trauma. The boys were called in front of the ICC and the whole matter was discussed in detail. The boys apologised in written and deleted the controversial photos from their mobile.


On 12/1/2023, an incident took place. Two girls from the commerce stream of the College prepared a movie showing the actions of drinking alcohol and smoking cigarettes, which went viral on Instagram. There was a discussion among the village people that the College girls of village have started drinking alcohol and smoking cigarettes. Hearing the discussion, the concerned girls were in a state of tension. Their parents felt bad. As soon as this incident came to light in the College, the girls concerned were called upon. The girl students explained that they made a movie by imitating it with similar literature and without any wrong intention, just as fun. The video, according to them, went viral by some mistake. They apologized for the mistake done in written form and promised that they would not do anything like this again. After that that the girls were permitted to attend the classes. Later on, the College, purposefully, through Student Counselling Cell, organized programmes on how to handle communication tools.

On 9/2/2023 a complaint was made that a girl student studying BA first year would tease his classmate, laugh at her, make fun of her and comment on her that she looked like a school giri, etc. The female student lodged a complaint, which was handed over to ICC by the Principal. The ICC called upon the accused student, his friend and elder brother and discussed the matter elaborately. The accused apologized and said that he would not do it again. Applicant girl student was assured that he would not do any wrong with her further and when she was convinced the matter was resolved.

Some grievances regarding washroom and classroom cleanliness were immediately resolved with the cooperation of the administration.

As the College is situated in the rural area, the ICC felt the need to educate the girls, it has conducted awareness programmes on gender sensitization, under Azadi ka Amrut Mahotsav. Tiranga Rally on 11/08/2022

On 17/08/2022, a gathering was organized for adolescent girls under the theme of women's health. Which was addressed by Dr. Sharyu Khakale, Dr. Todkari, Dr. Ikkar.

कॉलेजमध्ये विद्यार्थ्यांपैकी अर्धी संख्या मुलींची आहे. मानवत शहराव्यतिरिक्त आजूबाजूच्या छोट्या गावातून मुली शिक्षणासाठी महाविद्यालयात येत असतात. समिती मार्फत नेहमी प्रयत्न केले जातात की त्या मुलींना इतर कुप्रवृत्तीचा काही त्रास होऊ नये. व मुलींना प्रोत्साहन देण्यात येते की त्यांनी गावाच्या बाहेर पडल्यापासून घरी येईपर्यंत कोणत्याही त्रासाला बळी पडू नये. काही त्रास होत असेल तर सांगावे किंवा लेखी अर्ज द्यावा. असे आढळून आले की मानवत शेजारी गावी राहत असलेल्या मुलींना त्रास होतो. येता जाता पाच सहा दिवसापासून काही बाहेरची मुली सोबत चालण्याचा प्रयत्न करतात. मुलीकडे पाहतात, शेरे ओढतात, मोबाईल नंबर विचारतात, अशा प्रकारची तक्रार मुलींनी केल्यानंतर प्राचार्यांच्या मार्फत पोलिसांना कळविण्यात आले. चिडीमार पथक, फौजदार साहेबांनी स्वतः लक्ष घालून त्या मुलींशी संवाद साधले. विचारपूस केली सतत पाठलाग करून प्रश्न सोडविण्यात आले.

तसेच ऑनलाईन शिक्षणासाठी व्हाट्सअप ग्रुप करण्यात आले त्यामुळे काही बाहेरच्या मुलांनी आणि इतर वर्गातल्या मुलांनी काही मुलींचा मोबाईल नंबर घेऊन अनावश्यकरीत्या बोलण्याचा प्रयत्न केला. त्यामुळे विद्यार्थिनींना मानसिक त्रास झाला. अशा मुलींनी संबंधित मुलांची फोन नंबर अंतर्गत तक्रार निवारण समितिकडे दिली. ज्याच्याकडून त्यांना फोनवर विनाकारण व जबरदस्तीने बोलण्यात आले. तेव्हा समितीच्या सदस्यांनी अशा मुलांची फोनवरून बोलून चौकशी केली. त्यात काही मुले दोषी आढळली. त्यांना जाब विचारून गुन्ह्याची जाणीव करून दिली. त्या मुलांनी माफी मागितली पुन्हा तसे करणार नाही असे सांगितले. पुन्हा फोन नंबर घेऊ नये एवढेच मुलींचे म्हणणे होते. त्यांचे समाधान झाले व त्यांना न्याय देऊन आश्चस्त करण्यात आले.

महाविद्यालयातील विद्यार्थ्यांना सूचना देण्यात आली तसेच ग्रुप अडमिनने काळजी घेतली. विद्यार्थ्यांना अशा बाबी नियम विरुद्ध आहे व त्यामुळे कोणत्या प्रकारच्या शिक्षा होऊ शकतात याचे भान ठेवावे. म्हणून विद्यार्थ्यांना ताकीद करण्यात आली.

INTERNAL COMPLAINTS COMMITTEE (ICC) FOR WOMEN Committee Report for Academic Year 2021-22

Internal Complaints Committee (ICC), is a statutory committee constituted as per the guidelines of Maharashtra Public University Act 2016. ICC, under the able guidance of the Principal, is striving hard for the safety of girl students and women staff in the College. The committee takes every possible step towards gender sensitization, gender equality and organizes various programs for women empowerment under the guidance of IQAC.


More than fifty percent of the students enrolled in the college are girl students from Manwat town and the villages nearby. Efforts are made by the committee to ensure that the girls do not suffer from any mischievous act. The committee ensures girls safety right from the time they start from home till they return back to home. If they face any problem, girls are encouraged to give a written complaint to the Principal. The Principal calls a meeting of ICC upon receiving the complaints from the students and the issue is discussed in the meeting and resolved accordingly.

It was found that the girls living in the neighboring villages of Manwat sometimes suffered from the acts of mischief on their way to the College. During the Academic year 2021-22, six of such complaints were received and timely resolved by the Committee. The complaints were of the nature, that 'the boys tried to follow the girls with false intension': or that the boys passed derogatory comments or "the boys tried to talk even though the girls refused to talk', etc. when the girls could not bear the teasing, and were subsequently forced to approach the Principal, who, immediately convened a meeting of the ICC to investigate the matter. The ICC conducted thorough investigation and found the boys guilty. In five out of six cases, the boys were given warning and were counselled not to indulge in such acts. In one case, the boy's response was very casual and evasive and he behaved in a very rude manner. He was later handed over to the police. In this way, the complaints were timely resolved avoiding further embarrassment to the girls.

National Seminar on Gender Sensitization was organized on 27/11/2021. To which Dr. Rakesh Chandra, Principal, Lucknow University, Lucknow delivered the inaugural address. Also, Dr. Padmarani Rao and Dr. Yogini Satarkar addressed in different sessions. More than hundred delegates participated in the above seminar.

On the occasion of International Women's Day (08/03/2021), college girls participated in debates, essays, posters, rangoli and poetry reading competitions.

A workshop on meditation and stress management was organized on 11/03/2022 in conjunction with International Women's Day. Dr. Guided by Ajay Gavane, Nanded.

Internal Complaints Committee (ICC) is one of the most important statutory Committee formed by the IQAC, specially for women grievances. It is very active committee and it works under the guidance of Principal. ICC always tries to maintain a healthy and safe environment for girl students and women employees in the college with a special focus on gender equality, gender-sensitization and prevention of sexual harassment.

The academic year 2020-21, was badly hampered by the pandemic of Covid-19. Hence most of the time the college was shut down, due to which the ICC received very few complaints. However, after the commencement of the college, some of the grievances were received by ICC. On 18/1/2021 at 2.30 PM. a girl complained about a student of another college teasing her in the College premises. After inquiry, the boy tried to explain the role behind the talk and he emphasized that the girl was also involved in the affair with him. The ICC, in the meeting investigated the matter and the parents were informed about the issue. The parents of both the parties gave undertakings. Then the girl was allowed to attend the classes. After follow-up of girl for a few days, no undesirable action took place and the matter was resolved.

Meanwhile some general complaints were received about the cleanliness of girls' toilets and scarcity of water therein, were also resolved successfully. The ICC along with Women Empowerment Cell organizes various welfare programmes for the students.

Jijau Jayanti was celebrated on 12/01/2021 in the college following the rules of covid. Faculty members of the college and some students actively participated in this programme. Women's Day was celebrated on March 8, 2021. On this occasion, a one-day national online seminar was organized on the topic 'Covid-19 and the Status of Women'. Dr. Priyanka Jog, Mumbai gave guidance on Women's Mental Health. Dr. Madhuri Kshirsagar, Parbhani gave detailed guidance on the issue of violence against women during the Covid pandemic. More than 100 delegates participated in this seminar.

२) एक दिवसीय कार्यशाळा सहभाग:



One of the most important statutory committee, Internal Complaints Committee (ICC), working under the guidance of the Principal, has been working hard for resolving women grievances related with the sexual abuse. ICC always tries to maintain a healthy and safe environment for girl students and women employees in the college with a special focus on gender equality, gender-sensitization and prevention of sexual harassment.

Some of the general grievances are resolved at the Principal level. But many times, if the complaint is serious, the Principal hands over the matter to the ICC. The ICC then calls meeting and investigates the matter. In the academic year 2019-20, the ICC received few complaints related to sexual abuse by the male students. The complaints were like 'male student following girl while going home from the College', 'some freaky comments by the male students at girls', 'asking for mobile numbers, though the girls refused to give the number', etc. The complaints were resolved timely so that the girl students felt safe in the College.

National Service Scheme on 13.01.20. celebrated Rashtramata Jijau Jayanti and Vivekananda Jayanti were celebrated. Vaishnavi Dahe. Mrs. Ms. Rekha Timbule. Aarti Talekar Ms. Ms. Nandani Sanve. Committee Report for Academic Year 2018-19

Internal Complaints Committee (ICC), working under the guidance of the Principal, has been formed by the Internal Quality Assurance Cell (IQAC), is a statutory committee working for resolving women grievances related with the sexual abuse, gender sensitization, etc. ICC always tries to maintain a healthy and safe environment for girl students and women employees in the college.

In case of any complaint, the girls are encouraged to approach the Principal. Some of the general complaints are resolved at the Principal level. But many times, if the complaint is serious, the Principal hands over the matter to the ICC. The ICC then investigates into the matter and suggests the Principal to take appropriate action to resolve the matter. In the academic year 2018-19, the ICC received some complaints from the girls. The complaints were: i) A boy tried to propose a girl, who was not at all interested in the proposal. ii) A girl complained that a boy was teasing her about her height. iii) Some girls complained about a group of boys standing near the gate of the College and staring at the girls in had manners. All these complaints were resolved timely with the help of the administration, and the ICC made sure that the incidents were not repeated.

Considering the fact that the College is located in the rural are, ICC felt the need to organize welfare programmes for the women. The ICC along with Women Empowerment Cell organized following programmes during 2018-19:

1. Women Health Check-up Camp (10.01.2019)
2. Health awareness camp (18.01.2019)
3. Legal awareness camp (14.02.2019)
4. Essay competition on 'Indian Constitution and Gender Equality' (06.03.2019)
