#### PRHAMBLE .:

Forging partnerships and building relationships with fellow institutions, agencies and NGOs will definitely lead to an active role in the society and subsequently to a meaningful achievement in the present globalized world. It is, in fact, the need of the hour to work m collaboration to achieve and maintain quality standards in Teaching Learning valuation, Research and Extension activities. This helps to produce quality student service and may also serve to complement skills and resources between the o parties. The institutes and NGOs should join their hands to improve the standards in the field. This collaboration will also help to tackle and find solutions to particularly, the local problems and work together for the sustainable development of the area.

In View of the increasing adverse effects of the global warming and other environmental hazards on human life on and of the campus. The College Management has decided to take appropriate measures to create awareness among the stakeholders on Water conservation, and other environmental factors affecting human life. As the College does not have the expertise, it has decided to rope in an NGO having proven track record in the field for not only making the campus green and pollution free but also conduct awareness programme for all the stakeholders. It is found that "Paramvishwa Foundation" a Nanded based Non-Governmental Organization (NGO) has been doing a great job in the fields like water conservation, rain water harvesting, green campus promoting alternative energy sources, etc.

Now, therefore, both the parties have decided to enter into this Memorandum of Understanding (herein after referred to as MOU), which defines the framework for the mutual cooperation set out in the following sections.

#### About KKMCM

KKM, College, Manwat was established in the year 1972 with degree level education in Arts, Commerce and Science streams. Since that time, the college has been at the forefront to formulate an academic leadership. The college has already completed three rounds of NAAC Accreditation in the year 2004, 2012 and 2018 with 2.65 and 2.28 CGPA cumulating B Grade in these three cycles. We have ISO, Green and Energy Audit certification in the year 2023.

Apart from receiving Best Examination Centre Award twice; the college was awarded with The Best College Award from the parent university in the year 2010. The College annual magazine 'Manwata' has set a record by winning state and university level prizes for more than ten times.

#### About PVF

Paramvishwa Foundation Nanded, established in 2017, is one of the Non-Government Organizations (NGO) based in Nanded, strives to create awareness among the people on the water conservation, water management, environment conservation, and understanding the various schemes of the government to help the people at the grassroots level to achieve its objectives.

#### BROAD AREAS OF COLLABORATION:

Both parties agree to develop the following collaborative activities in the chosen area of mutual interest, based on equality and reciprocity.

- i. Organizing Awareness programmes for the students, staff, parents and the general public on "Water Management/ Conservation/ Rainwater harvesting".
- ii. Maintaining Pollution free Campus (various measures).
- iii. Environmental conservation.
- iv. Conducting Green Audit

- Energy Conservation/ Alternative Energy Resources (Solar energy). Utilization of solar energy on the campus.
- vi. Disposal of e-waste.
- vii. Conducting Awareness for the Students and the Staff on careful use of water.
- viii. Management of solid waste by composting it in organic manure.

A specific plan will be worked out for each activity, setting forth detailed arrangements for collaboration will be agreed. Terms and conditions for each visit or an assignment or such exchange, including the financial liabilities will be decided mutually as and when the need arises between the parties. A separate agreement will be entered into giving such details including terms of exchange of any intellectual property. KKMCM and PVF do hereby agree that the detailed terms and conditions that guide each activity identified above will be determined separately and agreed upon by the two parties as and when needed. These terms shall include a technical description of the proposed activity, financial arrangements, and person(s) responsible for its implementation.

#### ARTICLE 1: COORDINATION

Each institution shall appoint one member of its teaching/research faculty to coordinate the programme on its behalf. Further, a coordination committee consisting of a programme coordinator from the side of KKM College, Manwath and the President from the side of Paramvishwa Foundation, Nanded, will periodically review and identify ways to strengthen cooperation between the two institutions.

#### ARTICLE 2: DISCLAIMER

This MoU is not intended by KKMCM and PVF to constitute, create and give effect to any formal business organization of any kind. Each party hereto shall act as an independent entity, and neither shall act as an agent of either organization for other purposes. Neither party has the authority to bind the other party.

#### ARTICLE 3: NON-EXCLUSIVITY

The agreement reflected by the provisions of this MoU are non - exclusive in nature and both the parties can enter into cooperative arrangements with any other parties to suit their organizational needs.

#### RTICLE 4: CONFIDENTIAL INFORMATION

KKM College, Manwath & Paramvishwa Foundation, Nanded will not absolve any confidential information during the research activity.

#### ARTICLE 5: INTELLECTUAL PROPERTY RIGHTS

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MOU shall be vested in both the institutes to this Memorandum.

Both parties shall have the joint right to determine the commercial exploitation and disposition of such intellectual property, and both the institutes shall make joint applications for the registration of the same. Before any registration or commercialization of any intellectual property takes place, the institutes agree to reach a separate agreement covering issues such as exploitation rights and revenue sharing. Any publication regarding such intellectual property shall only be possible with the prior written consent of both the institutes, such consent not to be unreasonably withheld. Both the parties shall be free to use perpetually the results arising out of the collaborating activities for its own internal teaching, research, educational, clinical and publication purposes without the payment of royalties or other fees to the other party.

#### ARTICLE 6: VALIDITY

The Memorandum shall remain in force for a period of FIVE years commencing from the effective date. Institutions may extend the term by written agreement signed by both after a formal review.

#### ARTICLE 7: TERMINATION

Either institution may terminate the MOU by giving written notice of Six months in advance to the other institution. Once terminated, neither KKM College, Manwath nor Paramvishwa Foundation, Nanded will be responsible for any losses, financial or otherwise, which *the* other institutions may suffer. However, both shall continue to apply to all activities in progress until their completion.

#### ARTICLE 8: AMENDMENTS/MODIFICATIONS

This MOU may be amended or modified by a written agreement signed by the representatives of both the institutes.

#### ARTICLE 9: ADHERENCE TO LAWS

Participating faculties, staff and *students* involved in any activity under this Memorandum must adhere to the rules and regulations of the participating institutions.

#### ARTICLE 10: LEGAL IMPLICATIONS

Nothing in this Memorandum shall be construed as creating any legal patronship between the institutes. This memorandum is a statement of intent to foster enuine and mutually beneficial collaboration.

#### ARTICLE 11: DISPUTE RESOLUTION

In case, there be a dispute relating to any aspect of academic cooperation, KKM College, Manwath and The President, Paramvishwa Foundation, Nanded will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility. In witness whereof, each of the parties has caused this MoU to be executed in Two originals, abuse has to be retained by KKMCM and the other by PVF on this day.
